SS: Affidavit of Rev. Timothy Lee Fink

I, Rev. Timothy Lee Fink, was the pastor of Suburban Heights Baptist Church in Garfield Heights, Ohio, during the years of 1991-1999. While I was pastor, I remember Steven Crofts bringing two boys to our Awana program. Steven Crofts was not a member of our church, but he knew the Awana program was good for the children in the neighborhood. I left Suburban Heights Baptist Church to take on a missionary position in Romania in February of 1999. As of that time, I was not aware of the allegations the boys made about our Awana program, and how their statements proved criminal intent. Awana is not an "all gay" church or organization. You may contact the Awana organization headquarters in Streamwood, IL to substantiate this. During the time that I was Pastor of Suburban Heights Baptist Church, we believed and taught that homosexuality is a sin, and if the subject had come up, we would have taught these boys the same thing. If these boys said that our church was "all gay" or connected to the Roman Catholic Church, then their statements were not true.


