Now comes Petitioner, Steve Crotts, acting in the Pro se, and pursuant to Rule VII, Section 7 of the Rules of Practices of the Supreme Court of Ohio, and hereby presents this Final Addition to the previously filed Application for Writ of Habeas Corpus: In compliance with 2725 of the Revised Code, Petitioner at this time asks this Court to grant the Writ of Habeas to produce the body and file a Return of Writ. The Petitioner has not been able to obtain all of the discovery and the only commitment papers are the order of the Court within the Sentencing Journal Entry which have already been included. In *Watkins v. Collins*, 57 N.E.2d 78, the Court ruled Sentencing Journal Entries are sufficient. Therefore, should the Court wish to order an evidentiary hearing, Keith Yeazel has replaced Dennis Pusatovi.

## **Order of Ohio Supreme Court for Return of Writ**

In Habeas Corpus. On petition for writ of habeas corpus of Steven Crotts.

It is ordered by the court, sua sponte, that the writ is allowed. Allowing the writ means only that a return is ordered.

It is further ordered that respondent shall file a return of writ within twenty days of service of the petition, and petitioner may file a response within ten days after the return is filed. Respondent shall provide a copy of the return to the petitioner on the same date that the return is filed. Petitioner's physical presence before the court is not required.
