



BRIEF

Respondent's requests to supplement the record by inclusion of fourteen documents; eleven refer to respondent and three are about attorney Robert Broeren. The documents, mostly news accounts or online posts concerning this disciplinary case, are similar to exhibits already introduced at hearing. As such, at best, they constitute cumulative or duplicative evidence.


Respondent provides no compelling reason why the court should deviate from its policy of generally denying requests to supplement after the case is scheduled for oral argument. The court has not been amenable to supplementing the record even in cases in which the proposed supplemental evidence was not duplicative or cumulative of evidence already provided at hearing. Disciplinary Counsel v. Lentes, 2008-Ohio-6355; Columbus Bar Association v. Finneran 1997-Ohio-286. No valid basis to supplement the record is presented in this action.

For the foregoing reason, the instant request ought to be overruled.
