


**RELATOR'S NOTICE OF APPOINTMENT  
OF MONITORING ATTORNEY**

By Order filed on July 21, 2010, the Supreme Court of Ohio suspended Respondent Bradley M. Kraemer from the practice of law in the State of Ohio for two years, with one year stayed on the conditions that respondent: (1) continue to participate in mental-health counseling; and (2) complete a two-year term of probation monitored by relator in accordance with Gov. Bar R. V(9), following his return to the practice of law. Following the Court's suspension order, respondent filed his application for reinstatement. By Order on September 2, 2010, the Supreme Court of Ohio reinstated respondent to the practice of law in Ohio. The Court further ordered that relator, Disciplinary Counsel, file the name of the attorney who will monitor respondent during his two-year probation.

Now comes relator and hereby notifies this Court that Myron Auer Wolf of Hamilton, Ohio, Attorney Registration Number 0006372, has agreed to monitor respondent during the period of his probation until September 2, 2012. At the conclusion of respondent's probation, as ordered, relator will file a report indicating whether respondent has complied with the conditions of probation and monitoring by relator.
