


MOTION FOR APPOINTMENT OF COUNSEL

Now Comes, the Defendant-Appellant Stephen M. Lester, acting in propria persona, and respectfully moves this Honorable Court pursuant to S.Ct.Prac. R.3.7 to appoint counsel to represent Defendant-Appellant.

This Court on September 29, 2010 had accepted the appeal in case number 2010-1007 and determined that a conflict exists in case number 2010-1372. The Court had also ordered that these aforementioned cases to be consolidated.

According to S.Ct.Prac.R.3.7, if this Court grants leave to appeal in a discretionary appeal involving a felony and an unrepresented party to the appeal is indigent, this Court would appoint the Ohio Public Defender or other counsel to represent an indigent party.


