

After being duly sworn according to law, Affiant, Thomas H. Vogtsberger, hereinafter referred to as Respondent, does hereby depose and state that, with regard to the order of The Ohio Supreme Court of September 17, 2008, as follows:

1. Respondent has paid all fines and costs of the proceedings as ordered by the Supreme Court of Ohio.
2. Respondent has fully complied with the order of suspension. In that Respondent was under an order of indefinite suspension in the matter of *In re Report of the Commission on Continuing Legal Education, Thomas H. Vogtsberger*, case no. CLE-2005-23305, Respondent had previously terminated his practice of law and had no matters then pending. Consequently, Respondent had no clients or other co-counsel to notify of Respondent's suspension and consequent disqualification to act as an attorney after the effective date of said order. Respondent has periodically since the date of his suspension, returned files, documents, or other such property to former clients when requested to do so.
3. Respondent has complied with the continuing legal education requirements of Gov. Bar R. X. Section 3 (G).
4. There are no formal disciplinary proceedings pending against the Respondent.

5. The term suspension of two years for misuse of Respondent's IOLTA account terminated on September 17, 2010.

6. On May 16, 2006 Respondent was suspended from the practice of law for failure to comply with the applicable continuing legal education provisions of Gov. Bar. X and Gov. Jud. R IV for the 2003-2004 reporting period in the matter of *In re Report of the Commission on Continuing Legal Education, Thomas H. Vogtsberger*, case no. CLE-2005-23305. With regard to that suspension order, Respondent has:

7. Paid all fines and costs of that proceeding as ordered by the Supreme Court of Ohio.

8. Has fully complied with that order of suspension, including notification of all clients of Respondent's suspension and consequent disqualification to act as an attorney after the effective date of said order and returned to all such clients any papers or other property of said clients upon their requests.

9. Has complied with the continuing legal education requirements of Gov. Bar R. X.

Section 3 (G).

10. Has filed an affidavit of compliance in that matter.
