
**EXPLANATION IN SUPPORT OF APPELLANT'S MOTION TO WITHDRAW
REQUEST FOR TEN-DAY EXTENSION OF TIME TO FILE MERIT BRIEF**

On September 29, 2010, the Court accepted this case as a discretionary appeal (2010-0985). The record was filed on October 20, 2010 and the Appellant's Merit Brief was due on the 29th of November, 2010. Pursuant to S. Ct. R. XIV, Section 3, undersigned counsel for the Appellant requested a ten-day extension of time to file the Merit Brief, which request was filed November 23, 2010. Pursuant to that request, the new due date for Appellant's brief would be December 9, 2010. Prior to filing the request for a ten-day extension, unsuccessful efforts were made to contact Adrienne H.
