


Re: *Disciplinary Counsel v. J. Michael Nicks*, Case No. 2009-1544

Dear Ms. Grosko:

Enclosed is a copy of the continuing legal education record of John Michael Nicks, attorney registration number 0073608 as of December 6, 2010 (Exhibit 1). A review of his record indicates that since February 25, 2010, he has reported completing five (5) approved CLE activities for a total of 5.0 CLE credits. Of this amount, 2.0 hours were awarded for instruction in professional conduct.

Because the two activities are self-study courses, they appear on the transcript dated January 1, 2010 and February 3, 2010. These dates represent the dates the self-study activities were initially approved for the year 2010. The Ohio State Bar Association, the sponsor for these courses, has confirmed that Mr. Nicks completed activity #208187 and activity #211478 on October 6, 2010 and October 5, 2010, respectively.

A review of the continuing legal education records indicates that Mr. Nicks is not in compliance with Gov. Bar R. X. Specifically on June 6, 2008, the Supreme Court sanctioned Mr. Nicks for failure to comply with Gov. Bar R. X for the 2007 reporting period and ordered him to pay a \$350 sanction on or before July 7, 2008. As of the date of this order, Mr. Nicks has not paid this sanction.
