




**CLAIM DETERMINATION ENTRY**

In Re Application of Kathy M. Fairrow v. Rebecca Elizabeth Bobb  
Claim Number 09-0144

This cause came on for hearing before the Board of Commissioners of the Clients' Security Fund this 3<sup>rd</sup> day of December, 2010 on the application of Kathy M. Fairrow alleging a loss in the amount of \$2,776, caused by dishonest conduct of an attorney duly licensed to practice in the State of Ohio

The Commissioners of the Clients' Security Fund of Ohio find that:

- a) An attorney client relationship did exist between the claimant and Rebecca Elizabeth Bobb.
- b) The claimant suffered a loss of \$2,776 on or about March 5, 2009.

The Commissioners further find that the dishonest conduct consisted of theft of unearned fees, and that the following disciplinary proceedings were taken:

**Resigned-Discipline Pending on 9/24/2010**

The Commissioners further find that the claimant took affirmative action against the attorney within one year of becoming aware of the loss; and that there is no insurance or bond which will benefit the claimant; and that said claimant is not a spouse, close relative, partner, insurer or bonding company, nor a governmental unit.

Therefore the Commissioners of the Clients' Security Fund do hereby determine that the claim of Kathy M. Fairrow is eligible for reimbursement in the amount of \$2,776.

Payment of said amount is conditioned upon claimant complying with the subrogation assignment and other requirements of Sec. 6 of GOV. Rule VII of the Ohio Supreme Court.
