STATE'S MOTION TO SET EXECUTION DATE


This Court stayed execution of the sentence of death by entry dated October 3, 1996. Subsequent to that date the Ninth District Court of Appeals affirmed the denial of Phillips' petition for post-conviction relief. *State v. Phillips* (Feb. 27, 2002), 9th Dist. App. No. 20692. This Court denied review of the decision of the court of appeals. *State v. Phillips* (2002), 95 Ohio St.3d 1488.

The United States District Court denied Phillips' petition for writ of habeas corpus. *Phillips v. Bradshaw* (2006 N.D. Ohio), 2006 WL 2855077. The Sixth Circuit Court of Appeals affirmed. *Phillips v. Bradshaw* (6th Cir. 2010), 607 F.3d 199. The Supreme Court of the United States denied certiorari. *Phillips v. Bradshaw* (2011), 2011 WL 767607.

The Ohio Assistant Attorney General who litigates federal litigation has indicated that there is no pending federal litigation that would delay the execution of Ronald R. Phillips. The State requests that this Court set an execution date in this case.
