

CLAIM DETERMINATION ENTRY

In Re Application of Eleanor W. Blackburn Rev. Living Trust v. Kenneth Norman Shaw
Claim Number 09-0161

This cause came on for hearing before the Board of Commissioners of the Clients' Security Fund this 4th day of March, 2011 on the application of Eleanor W. Blackburn Rev. Living Trust alleging a loss in the amount of \$12,250, caused by dishonest conduct of an attorney duly licensed to practice in the State of Ohio

The Commissioners of the Clients' Security Fund of Ohio find that:

- a) An attorney client relationship did exist between the claimant and Kenneth Norman Shaw.
- b) The claimant suffered a loss of \$12,250 on or about November 3, 2008.

The Commissioners further find that the dishonest conduct consisted of theft by deception, and that the following disciplinary proceedings were taken:

Suspended For Term on 9/23/2010

The Commissioners further find that the claimant took affirmative action against the attorney within one year of becoming aware of the loss; and that there is no insurance or bond which will benefit the claimant; and that said claimant is not a spouse, close relative, partner, insurer or bonding company, nor a governmental unit.

Therefore the Commissioners of the Clients' Security Fund do hereby determine that the claim of Eleanor W. Blackburn Rev. Living Trust is eligible for reimbursement in the amount of \$12,250.


