



**CLAIM DETERMINATION ENTRY**

In Re Application of Michael R. Cotton v. Dale Paul Zucker  
Claim Number 09-0223

This cause came on for hearing before the Board of Commissioners of the Clients' Security Fund this 4<sup>th</sup> day of March, 2011 on the application of Michael R. Cotton alleging a loss in the amount of \$11,925, caused by dishonest conduct of an attorney duly licensed to practice in the State of Ohio

The Commissioners of the Clients' Security Fund of Ohio find that:

- a) An attorney client relationship did exist between the claimant and Dale Paul Zucker.
- b) The claimant suffered a loss of \$11,925 on or about October 23, 2009.

The Commissioners further find that the dishonest conduct consisted of theft by deception, and that the following disciplinary proceedings were taken:

**Resigned-Discipline Pending on 6/26/2007**

The Commissioners further find that the claimant took affirmative action against the attorney within one year of becoming aware of the loss; and that there is no insurance or bond which will benefit the claimant; and that said claimant is not a spouse, close relative, partner, insurer or bonding company, nor a governmental unit.

Therefore the Commissioners of the Clients' Security Fund do hereby determine that the claim of Michael R. Cotton is eligible for reimbursement in the amount of \$11,925.


