

**STIPULATION TO AGREED EXTENSION OF TIME  
UNTIL MAY 23, 2011 FOR APPELLEE TO FILE MERIT BRIEF**

Appellant Sager Corporation (a dissolved Illinois corporation) ("Sager") and Appellees, All Plaintiffs Represented by Bevan & Associates, L.P.A., through their undersigned counsel, file this Stipulation to Agreed Extension of Time Until May 23, 2011 for Filing of Appellees' Merit Brief and state as follows:

1. The record in this case was filed, and the Clerk of the Supreme Court gave notice of the filing of the record, on February 1, 2011, in accordance with S.Ct. R. Prac. 5.3.

2. Ohio S. Ct. Prac. R. 14.3(B)(2)(a) provides that "parties may stipulate to extensions of time to file merit briefs ... under S.Ct. Prac. R.6.2 ... not to exceed 20 days[.]"

3. Pursuant to S.Ct. Prac. 14.3(B)(2)(a) Appellant Sager received a stipulated extension of 20 days, until April 4, 2011, to file its Merit Brief.

4. Appellant filed its Merit Brief on April 4, 2011.

5. Appellees' Merit Brief is currently due on May 3, 2011.

6. Appellant and Appellee, through undersigned counsel, have agreed to an extension of time for 20 days, for Appellees to file their Merit Brief.

7. The 20th day after May 3, 2011 is May 23, 2011.

8. Accordingly, Appellant and Appellees stipulate to an agreed extension until Monday, May 23, 2011 for Appellees to file their Merit Brief.


9. Pursuant to S.Ct. Prac. R. 6.4(A)(2), Appellant's Reply Brief will be due twenty days later.

10. Appellees have not previously requested any extension of time.


