**EXPEDITED JOINT MOTION FOR STAY**  
**PENDING SETTLEMENT NEGOTIATIONS**


Pursuant to S.Ct. Prac. R. 14.4, Appellant Colerain Township and Appellee Rumpke Sanitary Landfill, Inc., jointly move for a stay of proceedings before this Court pending settlement negotiations among the parties.

This matter is before this Court after years of negotiation and litigation regarding Appellee's use of its land. This Court declined to exercise jurisdiction over this matter on April 20, 2011. Appellant filed a motion for reconsideration, which Appellee opposed and is now ripe for decision. In the interim, the Parties have continued negotiations to resolve their differences, which go beyond the instant case.

The Parties are aware that the Court may announce its decision on Appellant's motion as soon as June 22, 2011. The Parties believe that they are on the cusp of resolving their differences, and that maintaining the status quo of this matter for a short time may facilitate a final resolution. Accordingly, Appellant and Appellee jointly request a short stay of this matter.

If a stay is granted, the Parties are prepared to report to the Court by June 30, 2011 whether they have resolved their differences.




