INTRODUCTION

On June 30, 2009, this Court filed an order reinstating respondent to the practice of law. In the same order, the Court ordered respondent be placed on probation for two years until June 30, 2011.


Under Gov. Bar R.V(9), relator appointed Attorney Thomas Pyper to monitor respondent's probation. Now comes relator, Disciplinary Counsel, and submits a report regarding respondent's compliance with probation.

RELATOR'S REPORT

Pursuant to this Court's July 8, 2008 order, respondent was suspended from the practice of law for six months, followed by two years of probation. On June 30, 2009, the Court reinstated respondent to the practice of law, thus triggering respondent's two-year probationary period. Under Gov. Bar R.V(9), relator appointed Attorney Pyper to monitor respondent's conduct, with special emphasis on respondent's management of his operating and IOLTA accounts. In conformance with his duties as a monitoring attorney, Pyper provided relator with periodic reports, which indicated that respondent was in full compliance with the terms of his probation. At no time during respondent's two-year probation period did relator receive a report of a probation violation. Further, relator's review of the periodic reports submitted by Attorney Pyper indicates that Attorney Pyper has fully complied with his duties as the monitoring attorney.

In consideration of all of the foregoing and upon the submission of this report, this Court may now consider respondent's application for termination of probation.


