In support hereof he states as follows:

1. On November 15, 2006 this Court imposed an indefinite suspension; Toledo *Bar Assn. v. Crossmock*, 111 Ohio St.3d 278, 2006-Ohio-5706.
2. Respondent has paid all costs assessed against him arising out of the disciplinary case and is depositing an advance for costs associated with this petition for reinstatement;
3. Respondent has complied fully with all of the requirements in the order of suspension;

4. Respondent has complied with all of the continuing legal education requirements of Gov. Bar R. X, Section 3(G);
5. Respondent possesses all of the mental, educational, and moral qualifications that were required of an applicant for admission to the practice of law in Ohio at the time of his original admission;
6. Respondent is now a proper person to be readmitted to the practice of law in Ohio, notwithstanding the previous disciplinary action;


