

BRIEF IN SUPPORT OF MOTION

Relator, Akron Bar Association, respectfully requests the Court to grant an addition fifteen (15) days for it to file its response to Respondent Groner's Objections and Brief.

This Motion is not made for purposes of delay. Rather, Relator needs additional time to adequately respond to the Objections and Brief. Additional time is required because the press of other business in undersigned counsel's office, as well as the summer vacation schedule of staff and attorneys has rendered us unable to research, draft and file an adequate response by July 20, 2011.

This Court's Order of May 25, 2011 indicated that any answer brief may be filed on or before 15 days after the filing of any brief in support of objections. Both the objections and the

brief in support were filed on July 5, 2011. That date included an extra 20 days for Respondent to file, which was stipulated to by undersigned counsel.

As we read the Order to show cause, Relator's brief is due today, July 20, 2011. For the reasons set forth above, Relator respectfully requests the Court to allow it an additional 15 days, or until August 4, 2011, for Relator to file its responsive pleading in this matter.

Undersigned counsel called Respondent Groner's office on July 20, 2011, to request her approval of this Motion. Respondent was not at the office and undersigned counsel left a message on Respondent's voicemail. Due to the fact that this must be filed by facsimile today, undersigned counsel will keep the Court advised when he hears from Respondent Groner with regard to whether or not she has any objection to this motion to enlarge time. No objection is anticipated, as both parties previously stipulated to a 20-day extension for Respondent to file her objections.

For all these reasons, Relator respectfully urges the Court to grant its Motion to Enlarge Time for Relator to file its Brief, until August 4, 2011.


