

1. That I have personal knowledge of the facts stated herein and I am competent to testify as to the truth of the same.
2. I am incarcerated in the care and custody of the Ohio Department of Rehabilitation & Correction, at the London Correctional Institution, due to a conviction and sentence in state court.
3.
