
AFFIDAVIT OF COUNSEL FOR GRIEVANT
IN RESPONSE TO RESPONDENT'S AFFIDAVIT

Respondent, Mark ~~██████████~~ ^{DAVIS}, has filed an "Affidavit of No Use Of Campaign Material Referencing Degrees" pursuant to the the November 4, 2011 Order issued by the Five-Judge Commission in this case. The Order states that Respondent shall immediately and permanently cease and desist from using campaign materials that indicate that he has earned more than two college degrees, that his major or minor areas of study are separate degrees, and that his Certificate in International Trade and development is a college degree. Despite the affidavit filed today by Respondent, he continues to violate the cease and desist order on his campaign website and campaign Facebook page.

Attached to this affidavit is a true copy of the "Home" and "About Mark Davis" pages of Respondent's campaign committee website and Respondent's Facebook page printed this afternoon, November 7, 2011, by the undersigned counsel. The date and time is reflected at the bottom right hand corner of each page. The home page states that he "has graduated with honors in degrees of Law, International Law, Finance, Economics, French and German from both Miami University and the Ohio State University." The "About Mark Davis" page states that "he was valedictorian of his high school class and then graduated with honors from Miami University with degrees in Finance, Economics, French and German." Regarding the Ohio State College of Law, it states, "Simultaneously, he earned a graduate degree in International Trade and development." His campaign Facebook page, which is linked with his campaign website, states ". . . then graduated with honors from Miami University with degrees in in Finance, Economics, French and German."


Respondent's affidavit addresses only printed brochures and television commercials. However, the cease and desist order by its express terms applies more broadly to Respondent's "campaign materials" which would include on line materials promoting his candidacy. The introductory paragraph of Rule 4.3 of the Ohio Code of Judicial Conduct, specifically includes "electronic communications" in the prohibitions on false or misleading statements. Further, Respondent's affidavit states that he is distributing only the front page of his brochure with his picture and website. Indeed, it states, "For More Information Visit www.DAVIS4JUDGE.com" and "You can also find us on facebook (search "vote Mark Davis")."




