



**CLAIM DETERMINATION ENTRY**

In Re Application of Duncan R. Soles v. Harry Johann Wittbrod  
Claim Number 09-0170

This cause came on for hearing before the Board of Commissioners of the Clients' Security Fund this 2<sup>nd</sup> day of December, 2011 on the application of Duncan R. Soles alleging a loss in the amount of \$,4044.47, caused by dishonest conduct of an attorney duly licensed to practice in the State of Ohio

The Commissioners of the Clients' Security Fund of Ohio find that:

- a) An attorney client relationship did exist between the claimant and Harry Johann Wittbrod.
- b) The claimant suffered a loss of \$4,044.47 on or about September 24, 2008.

The Commissioners further find that the dishonest conduct consisted of theft of settlement proceeds, and that the following disciplinary proceedings were taken:

**Suspended Indefinitely on 9/21/2011**

The Commissioners further find that the claimant took affirmative action against the attorney within one year of becoming aware of the loss; and that there is no insurance or bond which will benefit the claimant; and that said claimant is not a spouse, close relative, partner, insurer or bonding company, nor a governmental unit.

Therefore the Commissioners of the Clients' Security Fund do hereby determine that the claim of Duncan R. Soles is eligible for reimbursement in the amount of \$4,044.47.

Payment of said amount is conditioned upon claimant complying with the subrogation assignment and other requirements of Sec. 6 of GOV. Rule VIII of the Ohio Supreme Court.


