**AFFIDAVIT OF PETITIONER HADIR HERMIZ AS TO SPECIFIC STATEMENT OF CLAIM FOR WHICH RELIEF MAY BE GRANTED.**

I, Hadir Hermiz duly deposes and state my claim for which relief may be granted is as follows:

1. I am the Petitioner in this case, trial court case numbers 2009-CR-02334, 2009-CR-04300, and 2010-CR-00746.

2. I completed 132 days of jail time in the Montgomery County Jail under the above mentioned case numbers and I have only been given 92 days j.t.c. I am seeking the difference of 40 days j.t.c. According to law I must be awarded 40 days days of j.t.c. **I am in jeopardy of being incarcerated past my true out date which is January 15, 2012** which would make me a unlawfully incarcerated inmate and the Department of Rehabilitation and Corrections would be liable.

3. According to Ohio Revised Code 2967.191 and OH ADC 5120-2-04(F). The trial court has the duty to reduce my sentence of incarceration by the time I have served.

4. I have a true and legal right to the jail time I completed to be applied to my case.

5. I, Petitioner Hadir Hermiz, have no other adequate legal remedy to gain the jail time credit I am legally entitled to have credited towards my sentence of incarceration. Therefore, a writ of mandamus in this instant writ is my only remedy.


6. I further state that I have a clear legal right to relief prayed for and that the Respondent is under clear legal duty to perform the act. Additionally I have no plain and adequate legal remedy in ordinary course of law according to *State ex. rel, McCuller v. Ohio Adult Parole Authority* 123 Ohio App. 3D 425, 704 N.E. 2D 324, (1997).

7. To cure the denial of my jail time credit, relief may be granted to me by:

(a) The Respondent on it's own credit 40 days of jail time credit to be awarded to me and update my out date to reflect the change.

(b) This Court order the Respondent, to credit 40 days of jail time credit to be awarded to me and to update my out date to reflect the change.
