STIPULATION TO EXTENSION

Pursuant to S.Ct. Prac. R. 6.3(A)(2), the merit brief of Appellee, the Public Utilities Commission of Ohio (Commission) must be filed by **February 9, 2012**.

Pursuant to S.Ct. Prac. R. 14.3(B)(2)(a), counsel for Appellant Columbia Gas of Ohio, Inc., the Commission, and Intervening-Appellee Cameron Creek Apartments have agreed to a twenty (20) day extension of the deadline for the filing of the Commission's merit brief.
