

NOTICE OF AUTOMATIC EXCLUSION OF PRO HAC VICE ATTORNEY

Dear Sir or Madam:

The records of the Office of Attorney Services indicate that the above-referenced out of state attorney registered for *pro hac vice* registration with the Office of Attorney Services for calendar year 2011 pursuant to Gov. Bar R. XII, "Pro Hac Vice Admission." These records also indicate that the attorney provided a "Notice of Permission to Appear *Pro Hac Vice*" with the Office of Attorney Services indicating that he or she was permitted to appear *pro hac vice* in the above-captioned matter during calendar year 2011. The attorney has not notified the Office of Attorney Services that this proceeding has concluded or that the attorney has withdrawn from the proceeding.


Gov. Bar R. XII, Sec. 5, provides that an attorney who continues to appear on the basis of permission to appear *pro hac vice* in any proceeding pending as of January 1, 2012, shall file with the Office of Attorney Services an updated registration form and pay a renewal fee by January 31, 2012. An attorney who fails to file a new registration form and pay the required renewal fee by January 31, 2012, shall be automatically excluded from practice in Ohio. The Office of Attorney Services shall notify all tribunals in which the attorney has appeared of the attorney's exclusion.

You are receiving this notice because it appears that the above-referenced attorney has not notified the Office of Attorney Services that he or she has withdrawn from the proceeding or that the proceeding has concluded. Further, this attorney has not filed with

the Office of Attorney Services a renewal registration application and paid the renewal fee as required by Gov. Bar R. XII, Sec. 5. Accordingly, the attorney is automatically excluded from practice in Ohio until such time as the attorney petitions for reinstatement and pays the *pro hac vice* renewal registration fee with the Office of Attorney Services.

If the attorney has withdrawn from the proceeding or if the proceeding has concluded, the attorney must notify the Office of Attorney Services. Please contact me at 614-387-9318 if you have any questions.
