

AFFIDAVIT OF COMPLIANCE
WILLIAM C. HELBLEY

WILLIAM C. HELBLEY, being first duly sworn and cautioned according to law, deposes and says as follows:

1. Affiant was admitted to the practice of law in the State of Ohio by the Supreme Court of Ohio on May 8 1989 and assigned Attorney Registration No. 0041660.

2. On or about February 14, 2012, the Supreme Court of Ohio issued an order directing that Affiant be suspended from the practice of law for an interim period.

3. Upon receipt of the February 14, 2012 Order, issued under Ohio Supreme Court Case No. 2012-0226, Affiant immediately ceased and desisted from the practice of law in any form, including appearances on behalf of any other individual, corporation, or other legal entity before any court, judge, commission, board, administrative agency, or other public authority.

4. Since receipt of the February 14, 2012 Order, Affiant has not counseled, rendered advice, or prepared legal documents for others; and, Affiant has not in any manner performed such services.

5. Affiant is cognizant of and will abide by the orders of the Supreme Court of Ohio directing that he is divested of all the rights, privileges, and prerogatives customarily accorded to a member in good standing of the legal profession of Ohio.

6. Affiant further is cognizant of his requirement to complete one credit hour of continued legal education for each month or portion of any month of the suspension imposed by the Court; and, the requirement to complete one credit hour of instruction related to professional conduct for each six months, or portion of any six month period, of the aforesaid suspension.

7. Affiant says that no reimbursements have been directed or are due any clients from the clients security fund, and Affiant is aware of no obligation to reimburse the clients security fund.

8. As required by the Supreme Court's Order, Affiant has notified all clients being represented in pending matters, and any co-counsel, of Affiant's suspension and consequent disqualification to act as any attorney. Affiant attaches hereto and incorporates by reference a sample form of the notification sent; and, Affiant says upon information and belief that all such clients and co-counsel have been properly notified.

9. Affiant has delivered to all clients who at the time of the suspension were being represented in pending matters, all papers or other property pertaining to the client; or, those items have been made available to all clients by notifying them of a suitable time and place for the papers or other property may be obtained.

10. Affiant is unaware of any fees or expenses that were unearned or not paid, and thus has refunded no such money; and, a client is in possession of no trust money to be accounted for.

11. Affiant has notified opposing counsel on all pending litigation of his disqualification to act as an attorney after the effective date of the aforesaid Supreme Court Order, and has filed the appropriate notice with all courts in which matters were pending where Affiant was acting as counsel. Incorporated by reference and attached hereto is a sample of that notification.

12. All notices required by the Supreme Court's February 14, 2012 Order were sent by United States Certified mail with postage prepaid; and, all such notices contained a return address where communications could thereafter be directed to Affiant, to-wit: 725 Boardman-Canfield Road, Suite K-2, Youngstown, Ohio 44512.

13. As required by Order of the Supreme Court, this Affidavit is being filed with the Clerk of the Supreme Court of Ohio and a copy is being forwarded to the Disciplinary Counsel of the Supreme Court of Ohio, including proof of service of all of the notices required by the Supreme Court's February 14, 2012 Court Order; and, as set forth above, Affiant may receive communications at 725 Boardman-Canfield Road, Suite K-2, Youngstown, Ohio 44512.


14. Affiant has retained and maintained a record of the various steps taken by him in order to comply with the February 14, 2012 Order of the Supreme Court of Ohio.
