RELATOR'S REPORT REGARDING RESPONDENT'S PROBATION


On December 21, 2010 the Ohio Supreme Court suspended respondent from the practice of law for a period of 12 months with the entire suspension stayed based on the conditions that respondent serve one year of monitored probation, comply with his existing Ohio Lawyers Assistance Program contract, and refrain from additional misconduct.

Pursuant to the Court's prior order, relator appointed a monitoring attorney for respondent who supervised the terms of respondents' probation. Relator has been advised by respondent's monitor that respondent has complied with all of the terms of his probation. Relator also received regular reports from the monitor.

CONCLUSION

In consideration of the foregoing, this Court may now consider respondent's application for termination of probation.
