Now comes the Respondent, Edward Rinderknecht, by and through counsel, and in response to the Court's Order to Show Cause states:


1. That he did not comply with the original order of the court. He has however, attached and incorporated hereto and affidavit of compliance executed on April 20, 2012,



AFFIDAVIT OF COMPLIANCE

Now comes the Affiant, EDWARD G. RINDERKNECHT, being first duly sworn according to law, deposes and states the following:

1. The Supreme Court of Ohio indefinitely suspended me from the practice of law on June 18, 1997, for breaching the disciplinary rules. I am submitting this affidavit of compliance, stating that I have fulfilled the requirements of the Board of Commissioners on Grievances and Discipline's June 18, 1997 order.
2. Consistent with Gov. Bar R. V, Sec. 6(B)(2), my last known business address in Cincinnati Ohio, was indefinitely suspended from the practice of law.
3. I immediately ceased and desisted from the practice of law in any form and have not, since my suspension, appeared on behalf of another before any court, judge, commission, board, administrative agency or other public authority.
4. Since my suspension, I have not counseled or advised or prepared legal instruments for others nor have I, in any manner, performed such services.
5. I surrendered my certificate of admission to practice to the Clerk of this Court after the Court's June 18, 1997 opinion, and my name was stricken from the roll of attorneys maintained by this Court.
6. I have paid the costs of these proceedings in the amount of Six thousand Three Hundred Ninety-One Dollars and Twenty-Eight Cents (\$6,391.28) within 90 days of the Court's order.

7. Pursuant to Gov. Bar R. X, Sec 3(G), I was required to complete one credit hour of continuing legal education for each month, or portion of a month, of my suspension and also required to complete one credit hour of instruction related to ethics and professional responsibility, including instruction on substance abuse, for each six months, or portion of six months, of my suspension. Since June 18, 1997, I have completed 172.25 CLE hours, 27.50 of which were awarded for instruction in professional conduct.

a. In addition, as of April 17, 2012 I have completed an additional 2.5 CLE hours, one hour of ethics, one hour of professionalism and 0.5 hour of substance abuse training.

8. On or before 30 days of June 18, 1997, I:

a. Notified all my clients in pending matters and any co-counsel of my suspension and my consequent disqualification to act as an attorney after June 18, 1997. I notified the clients to seek legal services elsewhere, calling attention to any urgency in seeking the substitution of another attorney in my place;

b. I delivered to all clients being represented in pending matters any papers or other property pertaining to the client and arranged for suitable time and place where the papers and property may be obtained, calling attention to any urgency for obtaining such papers and property.


c. I refunded any part of any fees or expenses paid in advance that were unearned or not paid, accounting for any trust money or property in my control or possession;

- d. I notified opposing counsel and adverse parties of my disqualification to act as an attorney after June 18, 1997, and filed notices of my disqualification with the court or agency before which the litigation was pending.
9. I have surrendered my attorney registration card for the 1995/1997 biennium.
10. I have kept the Clerk, the Cincinnati Bar Association, and the Disciplinary Counsel advised of any change of address. I currently live at 4669 Edgewater Dr. Sheffield Lake, Ohio 44054.
