
MEMORANDUM

The Board of Commissioners filed its Findings of Fact and Recommendation of the Board of Character and Fitness with respect to Applicant Eric Wilson on March 13, 2012. In its Recommendation, the Board of Commissioners on Character and Fitness recommended that Mr. Wilson be disapproved and that he be permitted to apply for the February 2016 bar examination by filing a new Application to Register as a Candidate for Admission to the Practice of Law and an Application to Take the Bar Examination. On March 21, 2012, this Court issued an Order permitting Objections to the Board's Findings of Fact and Recommendation within thirty (30) days. Applicant Eric Wilson filed his Objection to Report and Recommendation of the Board of Commissioners on Character and Fitness on April 19, 2012. Pursuant to this Court's Order and Gov. Bar Rule I, Section 12(F)(3) the Dayton Bar Association's answer brief is due on May 4, 2012.

The undersigned counsel received a time-stamped copy of Mr. Wilson's Objections from the Dayton Bar Association on April 24, 2012. The Dayton Bar Association has requested a copy of the transcript of the hearing in order to properly prepare an answer brief. As of the time of this filing, the undersigned counsel has not received a copy of the hearing transcript. In addition, the undersigned counsel has a full schedule over the next week. In order to review the transcript and prepare a proper answer brief, the Dayton Bar Association respectfully requests a ten (10) day extension of time, up to and including, May 14, 2012, to file its answer brief.
