
**AMENDMENT TO RELATOR'S WRIT OF MANDAMUS**




I, **La'Mon R. Akemon Jr.** a United State citizen and affiant herein, after being duly cautioned and sword, depose and say;

7. All of the averment and statement contain herein are true and correct to the best of my knowledge and belief.


