

Stipulation For Extension of Time to File Appellee's Merit Brief

Now come Defendant-Appellee Van Williams, as represented by Assistant State Public Defender Stephen Goldmeier, and the State of Ohio, as represented by Cuyahoga County Prosecuting Attorney William D.
