



**CLAIM DETERMINATION ENTRY**

In Re Application of Algernon Toole v. Stanley Jackson  
Claim Number 11-0055

This cause came on for hearing before the Board of Commissioners of the Clients' Security Fund this 8<sup>th</sup> day of June 2012 on the application of Algernon Toole alleging a loss in the amount of \$10,460, caused by dishonest conduct of an attorney duly licensed to practice in the State of Ohio

The Commissioners of the Clients' Security Fund of Ohio find that:

- a) An attorney client relationship did exist between the claimant and Stanley Jackson, Jr..
- b) The claimant suffered a loss of \$7,322 on or about Spring of 2006.

The Commissioners further find that the dishonest conduct consisted of theft by deception, and that the following disciplinary proceedings were taken:

**Suspended For Term on 11/30/2010**

The Commissioners further find that the claimant took affirmative action against the attorney within one year of becoming aware of the loss; and that there is no insurance or bond which will benefit the claimant; and that said claimant is not a spouse, close relative, partner, insurer or bonding company, nor a governmental unit.

Therefore the Commissioners of the Clients' Security Fund do hereby determine that the claim of Algernon Toole is eligible for reimbursement in the amount of \$7,322.

Payment of said amount is conditioned upon claimant complying with the subrogation assignment and other requirements of Sec. 6 of GOV. Rule VIII of the Ohio Supreme Court.
