

CLAIM DETERMINATION ENTRY

In Re Application of George Z. Hertelendy v. Frank Xavior Gresley
Claim Number 11-0027

This cause came on for hearing before the Board of Commissioners of the Clients' Security Fund this 8th day of June 2012 on the application of George Z. Hertelendy alleging a loss in the amount of in an undetermined amount, caused by dishonest conduct of an attorney duly licensed to practice in the State of Ohio

The Commissioners of the Clients' Security Fund of Ohio find that:

- a) An attorney client relationship did exist between the claimant and Frank Xavior Gresley.
- b) The claimant suffered a loss of \$150 on or about Spring, 2010.

The Commissioners further find that the dishonest conduct consisted of theft of Unearned Fee, and that the following disciplinary proceedings were taken:

Suspended For Term on 4/24/2012

The Commissioners further find that the claimant took affirmative action against the attorney within one year of becoming aware of the loss; and that there is no insurance or bond which will benefit the claimant; and that said claimant is not a spouse, close relative, partner, insurer or bonding company, nor a governmental unit.

Therefore the Commissioners of the Clients' Security Fund do hereby determine that the claim of George Z. Hertelendy is eligible for reimbursement in the amount of \$150.

Payment of said amount is conditioned upon claimant complying with the subrogation assignment and other requirements of Sec. 6 of GOV. Rule VII of the Ohio Supreme Court.


