I am writing to follow up on my call to you on today's date.



Judicial candidate Jeanette Moll ordered to stop using misleading flier

COLUMBUS — A five-judge panel has ordered 5th District Court of Appeals candidate Jeanette Moll to stop using a campaign flier that shows her in a judicial robe and describes her as Guernsey County magistrate.

BUSINESS NEWS

An interim order, issued Tuesday, requires Moll to contact every Republican Party headquarters in the 5th District and any other organization that received the fliers and request written assurances that any remaining copies will be destroyed or returned. The 5th District covers 15 counties, including Stark.

Moll must also personally inspect the Stark County Republican Party headquarters to ensure that no copies remain there.

The order was based on the recommendation of a hearing panel that previously found the flier creates a false impression because it doesn't explain that Moll is a former magistrate, having held that position from 1997 to 2007.

Moll said she is no longer using the literature and is fully complying with court orders.

SUGGESTED STORIES

In court papers, she denies the flier is misleading and asks that the complaint against her be dismissed on several grounds, including freedom of speech.

She also wrote that she has "personally undertaken all actions requested of her by the hearing panel to ensure that (the flier) is no longer in use."






