RESPONDENT BRIDGET M. MCCAFFERTY'S RESPONSE TO SHOW CAUSE ORDER

On July 19, 2012, Bridget M. McCafferty (Attorney Registration Number 0055367), attempted through her counsel to file an Affidavit of Compliance in response to this Court's Order of September 14, 2011. This Court's Order was never served on Ms. McCafferty, and has not been served upon McCafferty to date. However, McCafferty subsequently became aware of the Order, long after the window to file a timely Affidavit of Compliance had closed. She therefore attempted to waive service of that Order and voluntarily submit an Affidavit of Compliance on July 19, 2012. However, when it was submitted for filing, that filing was refused because the window of compliance (30 days from the original Order of September 14, 2011) had closed.

That attempted filing has likely triggered this Court's Show Cause Order of August 1, 2012, ordering Ms. McCafferty to show cause why she should not be found in contempt. The filing of that Show Cause Order has re-opened the window that enables Ms. McCafferty to again file her Affidavit of Compliance, which she has re-submitted to the Clerk, simultaneously with this Response. She wished to provide this explanation for her delay in doing so.

At the time her Affidavit of Compliance was refused for filing, the Clerk informed her counsel that they could enter an appearance on this case number. Therefore, they have done so today as well to be apprised of all prospective developments. Further, as indicated in her Affidavit of Compliance, Ms. McCafferty waives service of the Court's original Order of September 14, 2011; she accepts all new filings in this matter through her counsel.
