I need your assistance in making contact with the Superintendent of Cincinnati Public Schools, Mary A. Ronan. I am a former student of the Cincinnati Public Schools. I have a pressing matter that I need assistance with that is directly related to my time as a student in the Cincinnati Public Schools. I attended Cummins Elementary School, Schiel Elementary School, Merry Junior High School and Hughes High School. I need assistance in contacting a former employee that worked in the front office of the Schiel Elementary School as late as 1984 through 1987. This female employee had legal international documents on file that were left at the school for me to pick up; when my children reached adult hood. I have checked back with Schiel School a few years ago; problem is that the office school staff that was there when I last checked at the school in 1984 to 1985; have all retired or left for other positions. The employee is female white, approximately 5'4, medium build with dark brown hair. I don't remember her name. The documents were originally setup with the school back in the late 1960's, the agreement allowed me to return and pickup the documents and other items that I have sole rights/possession to. The legal international documents are in my name. I can provide various forms of identification that will verify me as the student with legal rights. The employees that were office clerks during the late to 1960's to early 1970's were most familiar with the documents and the items. I was required by my mother (Mrs. Maxine Jackson "nee" Baldwin). At the time I resided at 2804 Eden Avenue., Cincinnati, Ohio 45219; Tele# 1-513-751-2943. It is imperative that I retrieve the documents immediately if at all possible. The documents were left in a cabinet drawer the last time I checked in 1984-1985. I am certain that the Superintendent of Cincinnati Public Schools would be able to check through the school listings for employees working in the front school offices in 1984-1987. I would need contact made with the various employees who worked there at that time. I could meet with them at the school to retrieve the legal documentation/items. I would appreciate that the entire matter/request be kept confidential at this time. The clerk that made the arrangements for me to return for the documents would be familiar with me. I would appreciate a telephone number left on my cell phone message system as to where I could make direct contact with the Superintendent Ms. Ronan or your office as President of the Mayerson Academy. I am presently unemployed due to

layoffs; awaiting a graduate school bid. I have enclosed a couple of attachments that will give a general idea of my background since leaving High School.
