5. Therefore, I did not have any clients to inform of the Order, nor did I have any counsel to inform of the Order.





February 29, 2012

KENNETH LOUIS GOLDEN [#250521], 34, of West Hollywood was suspended for two years, stayed, actually suspended for 90 days and he was ordered to take the MPRE and comply with rule 9.20 of the California Rules of Court. The order took effect Feb. 29, 2012.

Golden was convicted in 2008 of misdemeanor false imprisonment and making criminal threats and stipulated that the crimes warrant discipline. He approached a van near Los Angeles airport in which the stepson of an individual who purportedly had made business investments for Golden was a passenger. Golden was disappointed that investments had not been made and yelled threatening statements at the stepson, who called police.

In mitigation, Golden had no prior discipline record and completed community service beyond that required after his conviction.






