
In accordance with the October 4, 2012, Order of the Supreme Court of Ohio, Patricia B. Fugee, of Toledo, Ohio, Registration Number 0070698, is hereby appointed as the attorney who will monitor respondent Beauregard M. Harvey's compliance with the terms of his probation.

The term of probation is one year from October 4, 2012, unless altered by the Court. At the end of that term, respondent may apply for termination of the probation.

The monitoring attorney shall:

1. Monitor compliance by respondent with the conditions of probation imposed by the Supreme Court.
2. Observe respondent's professional conduct.
3. Meet with respondent, personally or by telephone, at the monitoring attorney's option, at least once per month.
4. Satisfy herself that respondent is appropriately handling legal matters entrusted to him
5. Provide guidance and mentoring as appropriate.
6. Immediately report to the Bar Counsel any violations by respondent of either the terms of probation or the Rules of Professional Conduct.
7. Report to the Bar Counsel at least once per quarter, in writing, with the first report due on or before January 4, 2013.

The monitoring attorney shall verify respondent's compliance with the terms of probation in such reasonable manner as she may determine. The monitoring attorney may require more frequent meetings than monthly at her discretion.
