



Enclosed is a copy of the continuing legal education record of Harvey Cecil Miller, attorney registration number 0071490 as of November 13, 2012 (Exhibit 1). A review of the continuing legal education records indicates that Mr. Miller is in compliance with Gov. Bar R. X and has no outstanding fees or sanctions.


