

Motion for Permission to Appear Pro Hac Vice

Pursuant to Gov. Bar R. XII(2)(A)(6), Carrie Wood (“Movant”), attorney for Tyrone Noling, hereby moves this Court to grant Carrie Wood permission to appear pro hac vice and participate as counsel of record in this case after the expiration of Ms. Wood’s Temporary Certification to Practice Law in Ohio as an employee of the Ohio Innocence Project on November 30, 2012. Movant meets the requirements to appear pro hac vice, as outlined below.

Movant represents that the following is a list of jurisdictions in which Carrie Wood has ever been licensed to practice law, including dates of admission to practice, resignation, or retirement, and any attorney registration numbers:

Carrie Wood has been a member in good standing of the New York Bar since March 23, 2006. Ms. Wood’s attorney registration number in New York is 4397535. Permission to Appear Pro Hac Vice and a copy of the Order granting permission with the Supreme Court of Ohio Office of Attorney Services within thirty days of the Order.






