Pursuant to S.Ct. Prac. R. 9.8, and with regard to the State's assertion that an entry that does not contain a sentence can be a "judgment of conviction," Appellee Sandra Griffin submits the following additional authority:

Harvest Land Co-Op, Inc. V. Hora, 2d Dist. No. 25068, 2012-Ohio-5915, ¶ 62 ("To the extent that the issue . . . was inconsistent with the issues determined in the final order on review, we would agree that the magistrate lacked jurisdiction to file a decision. However, because the appeal in Case No. 24718 was not from a final order, the jurisdiction of this court was not invoked. The trial court and its magistrate were therefore not deprived of jurisdiction to adjudicate the issues before that court during the pendency of the appeal.").


