Now comes Marc E. Dann, Registration Number 0039425, being duly sworn and hereby verifies his compliance with the Court's Order of November 20, 2012:


1. As of November 20, 2012 affiant ceased and desisted from the practice of law in any form and did not appear on behalf another before any court, judge, commission, board, administrative agency or other public authority.
2. Until his employment relationship with Grace Doberdruk and Dan Solar of Doberdruk and Harshman was approved, affiant did not enter into any employment relationship with any attorney or law firm.
