**AFFIDAVIT OF INDIGENCY AND
MOTION TO WAIVE COSTS**

Robert Leon Schwartz

Now comes Robert Leon Schwartz, Respondent, who hereby presents this Affidavit of Indingeny and respectfully Moves to Waive Costs, as set forth in the Order of this Court filed December 12, 2012.

Robert Leon Schwartz, hereby states, under oath and to the best of his personal knowledge as follows:

1. An Order was issued by this Court on December 12, 2012, that Respondent be taxed the costs of these proceedings in the amount of \$1,439.20 and other charges, within 90 days of the order.
2. The Order further states that failure to pay shall result in an order of contempt and referral to the office of Attorney General for collection.
3. Respondent is currently serving a four year sentence in Federal Prison. He was ordered to pay more than \$6 Million in restitution. All of his money has been seized, garnisheed and taken from his posession, about \$1.2 Million. The rest of the restitution remains due and unpaid. There is a Federal Lien for the remainder. Such Federal lien will take priority and any efforts of further collection will be expensive and fruitless and futile.

Wherefore, it is respectfully moved that the amounts taxed upon Respondent be waived and excused due to the hardship of indingency of Respondent and his inability to pay, and that no Order of Contempt be issued.


