**INTRODUCTION**

**RELATOR’S REPORT**



Relator's evaluation of the reports submitted by Mr. Py indicates that respondent has complied with the monitoring requirements.


Further, a review of respondent's "application for termination of probation" and affidavit indicates that he has complied with all of the terms and conditions of his probation.


