




STIPULATION TO EXTENSION

Pursuant to S.Ct. Prac. R. 16.03(A)(2), the merit brief of Appellee, the Public Utilities Commission of Ohio ("Commission") must be filed by **March 28, 2013**.

Pursuant to S.Ct. Prac. R. 3.03(B)(2)(a)(i), counsel for Appellant The East Ohio Gas Company d/b/a Dominion East Ohio ("DEO") and counsel for the Commission have agreed to a twenty (20) day extension of the deadline for the filing of the Commission's merit brief. No prior extensions have been requested by the Commission. The new deadline for filing a merit brief by the Commission, pursuant to the agreement of the parties, is **April 17, 2013**. This stipulation will also extend DEO's deadline to file a reply brief, which will now be twenty days (20) from the date the Commission files its merit brief pursuant to S.Ct.Prac.R. 16.04(A)(2). If DEO requests an extension of time to file its reply brief, the Commission will not oppose such a request.


