I, Leotis M. Daggett, affiant herein, being duly advised as to the penalty for perjury and being competent to testify, do hereby affirm that the following enumerated statements are true and correct:

1. I am currently incarcerated at the Richland Correctional Institution and I am the Defendant in this action;
2. I am unable to secure funds without substantial hardship to my family or me;
3. I have no assets whatsoever, either in property or bank accounts from which to obtain the monies to pay the costs of this case;
4. I earn \$22 per month in "state pay" for prison work since the Court began collecting monies for costs in this case and I have no other income, therefore the current collection places and undue hardship on me to purchase the necessary toiletries that are not provided by the institution;
5. I hereby request the Court to stay further collection of costs until such time as I am released;
6. I understand that I must inform the Court if my financial situation should change before the deposition of the case for which waiver of payment is being provided; and
7. I understand that if it is determined by the county, or a Court, that waiver of costs or fines should not have been provided, I may be required to reimburse the county for the costs of this action as provided.
