5) He is also attaching hereto Notices to opposing counsel in pending litigation. Exhibits I through Q, in connection with para. 4 of The Order.


6) The forms filed in courts used to provide Notice of Disqualification of Counsel to all counsel in pending litigation are attached hereto as Exs. R through Z.




