This case is before the Court on the appeal by Ohio Partners for Affordable Energy from the January 9, 2013 Opinion and Order and the March 6, 2013 Entry on Rehearing of the Public Utilities Commission of Ohio in Case No. 12-1842-GA-EXM. The proceeding before the Commission was initiated by a joint motion filed under the authority of R.C. 4929.08 by DEO and an association of natural gas marketers for modification of an exemption order issued in a prior Commission case. 
