

STIPULATION TO EXTENSION

Pursuant to S.Ct. Prac. R. 16.03(A)(2), the merit brief of Appellee, the Public Utilities Commission of Ohio ("Commission") must be filed by **June 19, 2013**. Pursuant to S.Ct. Prac. R. 3.03(B)(2)(a)(i), counsel for Appellant Ohio Partners for Affordable Energy ("OPAE") and counsel for the Commission have agreed to a twenty (20) day extension of the deadline for the filing of the Commission's merit brief. No prior extensions have been requested by the Commission. The new deadline for filing a merit brief by the Commission, pursuant to the agreement of the parties, is **July 9, 2013**. This stipulation will also extend OPAE's deadline to file a reply brief, which will now be twenty days (20) from the date the Commission files its merit brief pursuant to S.Ct.Prac.R. 16.04(A)(2).
