

STIPULATION TO EXTENSION

Pursuant to S.Ct. Prac. R. 16.03(A)(2), the merit brief of Appellee, the Public Utilities Commission of Ohio (“Commission”) must be filed by **August 14, 2013**.

Pursuant to S.Ct. Prac. R. 3.03(B)(2)(a)(i), counsel for Appellant Pilkington North America, Inc. (“Pilkington”) and counsel for the Commission have agreed to a twenty (20) day extension of the deadline for the filing of the Commission’s merit brief. No prior extensions have been requested by the Commission. The new deadline for filing a merit brief by the Commission, pursuant to the agreement of the parties, is **September 3, 2013**. This stipulation will also extend Pilkington’s deadline to file a reply brief, which will now be twenty days (20) from the date the Commission files its merit brief pursuant to S.Ct.Prac.R. 16.04(A)(2). If Pilkington requests an extension of time to file its reply brief, the Commission will not oppose such a request.
