

STIPULATION

On July 31, 2013, the parties filed a stipulation to twenty-day extension of time to file Appellant's brief. That stipulation indicated that the filing due date would be Monday, September 2, 2013. Therefore, the parties respectfully request to correct the stipulation as follows:

As required by S.Ct.Prac.R. 3.03(B)(2)(a), counsel for Appellant and counsel for Appellee have agreed to a stipulated twenty-day extension of time to file Appellant's brief. The filing date for Appellant's brief is extended by stipulation from August 12, 2013 to September 1, 2013. Because September 1, 2013 is a Sunday and Monday, September 2, 2013 is Labor Day, pursuant to S.Ct.Prac.R. 3.03(A)(1), the actual filing date shall be Tuesday, September 3, 2013.


