


**JOINT MOTION TO SUPPLEMENT THE RECORD WITH THE PRESENTENCE  
INVESTIGATION REPORT, TO DIRECT THE LUCAS COUNTY CLERK'S OFFICE TO  
RETAIN A COPY, AND TO PERMIT COUNSEL FOR BOTH SIDES  
TO VIEW BUT NOT COPY THE DOCUMENT**

The parties jointly ask this Court to direct the Lucas County Clerk of Court to supplement the record with a sealed copy of the presentence investigation report ("PSI"). S.Ct.Prac.R. 15.08. Counsel for Mr. Belew has reviewed the lower court record in this Court's Clerk's Office, including the sealed documents already filed, but the PSI was not there.

This Court needs the report to fully consider this case. Mr. Belew pleaded guilty and his appeal concerns only sentencing issues, so the presentence investigation report contains critical details unavailable in other parts of the record.

The parties also ask this Court to direct the Lucas County Clerk to retain a copy of the PSI so that counsel for the State may view the document without traveling to Columbus simply for that task. Finally, the parties ask that counsel for each side be permitted to view, but not copy, the document at either the Lucas County Clerk's Office or at this Court's Clerk's Office.
